DRCC Public Advisory Council DRCC Education and Public Involvement Work Group

Wednesday, April 30, 2014 – 4:30 to 6:30 pm Airport Conference Room, Windsor, ON

- Welcome, introductions, approval of agenda (5 min)
- Tom called the meeting to order at 4:37pm. Welcomes all in attendance; Agenda approved by consensus.
- Approval of December 9, 2013 Meeting Record and Review of the following Action Items:
 - Natalie to determine if Amherstburg has CSO outlets and where they are located.
 - The PAC will review the report and provide comments to Natalie in writing before February 3 (done)
 - Tom will draft a letter to COA AIC Co-Chairs (Jon Gee (EC) and Dawn Walsh (MOE)) regarding the need for a revised COA (done) Tom wrote a letter to the Ministers with copies to John Gee and Mike Moroney urging fast passing of the Canada Ontario Agreement. Tom has heard that it is close to passing.
 - The PAC will review the report and provide comments to Natalie in writing by January 6 (done)
 - Tom will organize a meeting of the sub-committee for early January 2014 (done)
 - Ian Naisbitt will make a presentation on behalf of the PAC (and Lil'Reg) to request that a recommendation from WECEC to City Council be made to support this second phase of the Airport Swamps project (done) Phil reported that it went to the Standing Committee last week. The recommendation didn't make it February for reasons unknown. The meeting was cancelled for March. It just went to the SC for April; in the interim, it went to administration and then to Airport Authority – the Airport replied saying that they don't have an issue with financial loss or with it being a wildlife attraction. However, a number of land use issues in front of us, so it should be deferred. The land use issues are the City's - 1) the airport's environmental section of the Master Plan, identified 120m buffers around the woodlots not accepted by City Council (big challenge from St. Louis family) – the City's concern is where does the buffer start/stop? Meeting at the beginning of April to deal with buffer/adjacent land issue. A report is now going to council on that. 2) the mayor has announced a solar panel development here at the airport, and a concept of a regional hospital. 3) There has always been a notion that if we create a swamp woodland that you could develop a green infrastructure for storm water. The confusion is that, even though this is not a storm water feature, we would like to test it as if it were. The CA does not approve of that. A meeting is scheduled with Tim, John, Kate, Mike N, Mario, etc. to look at how this structure might look. Ultimately, the confusion is that it isn't a storm water feature. We have to go through this so we aren't challenged with wildlife attraction. It is important to hydrolically link these two woodlots. Earthworks for late 2014, then it will be ready for

tree planting in spring of 2015. The facility can't hold water – need to plant trees, get them established, then slowly introduce water. Phil is confident that we can move this forward, we have lost months of progress with the Standing Committee. We received an endorsement in principal.

- 3. PAC Update since December 9, 2013
 - a. Ojibway Shores (T. Henderson/S. Marks)
 - ECFNC involvement and surveys
 - On July 3rd there was a WPA open house that had excellent attendance. September 26th there was a smaller meeting with our Reps, ERCA, Brian Masse and WPA, and Jeff Watson. It was agreed at that meeting that the WPA would open up the OS property for the entire 2014 calendar year for the ECFN and ERCA to do a biological inventory. ECFN schedule of plans has been shared with Cree from the WPA. Tom wrote to the Windsor Star and it was printed – keeping OS front and centre. Tom has another suggestion for a solution: ex. Province provides compensation land. So, say to WPA, the Province is doing it – why don't you? For the group's consideration: the WPA will be well compensated for the land/air that is being used for the development of the new bridge. Perhaps we should be putting forward the idea that perhaps the MOT should be in some sort of compensation mode and provide OS as compensation for natural areas that will be destroyed by the plaza a bridge? Should Tom approach the WPA and the MOT to donate OS to the environmental community as a park/ERCA property whatever – as a part of the compensation package for the land which will be destroyed with the plaza? Phil noted that it is already one of the strategies that we have. Phil asked do we want to include the WPA at this point? Phil noted that the argument becomes stronger when we do some of our EA background work? He feels that it might be premature at this stage. Phil – are there any official details on this, or is this speculation? Freedom of information – what is their entitlement in regard to the bridge plaza land/air rights? Is there a payment in perpetuity planned? Is the number negotiated - has anyone assigned value to that and can we find out? Derek added that in our letters to the Ministers they have to do an environmental planning report – we have flagged that with both Ministers. They know that we are waiting and waiting to be notified. We are still waiting. Keep in mind Nature Conservancy of Canada, Ducks Unlimited, etc. and their existing relationship with the Feds. Phil – start with Masse and Watson – we are waiting for you guys to come back with some sort of solution on OS (Watson promised a March response). We understand that the WPA stands to make money on land and air rights – is this not compensation enough? That may be the way to form it. First, it is important for us to be sure that we know that they are going to get air rights and land rights compensation (a revenue stream based on the plaza and bridge development) let's leverage that. Tom asked if there should be a City of Windsor component? Mike Walsh – the City is under a legal obligation to complete infrastructure on that property by virtue of a previous land swap with the WPA

(within 6 months). That's a major item around the neck of the City. They make light of it, but it is a real requirement according to their legal department. The City has a real desire to get out from under that obligation, which they would if there was a land swap. The mayor is on his way out. Saving OS might be a nice environmental feather for the City's mayor to put into his hat. Dave thinks that at some future meeting with the larger group, the City shouldn't be let off of the hook. Pearl noted that we have to wait a bit – we aren't ready now.

- ACTION: Tom will continue research to find out what that kind of agreement looks like air/land rights agreement.
- ACTION: Tom to follow up with Jeff Watson to come back to us with his information (as promised) as we are beyond the date he originally noted.
- Essex County Field Naturalists' Update: They have done a nest distribution study last December – an early start to breeding bird activity. They are mapping the vernal pools (ephemeral ponds); they are scheduled to fly over the property to get aerial photos of the wet footprint of the property. The snake guys have put out monitoring boards on OS property and City of Windsor Properties. Joel Gagnon has two grad students looking for projects- they will start with geophysical work: native soils, fills, dump sites, hydrology, etc. A whole group (Jerry Waldron) will start on the plant species study. Breeding bird study / mist netting, to start soon.
- Tom and Phil, from a PAC standpoint, will contact Richard Wyma regarding his commitment that Dan Lebedyk will be able to do a land assessment study for us (committed on Sept. 26, 2013 at the WPA meeting). ACTION: Tom to draft an email and follow up with Richard.
- New Bridge
- b. Petcoke on U.S. side of Detroit River (T. Henderson) Tom reported that they want to store it downriver on the American side – American politicians have turned this down. That's good news, for now. Rick Coronado reported that there is a proposal to store petcoke in River Rouge. The issue is how does DEQ deal with it under these permitting issues. That area is right across from LaSalle.
- c. Western Lake Erie Watersheds Priority Area Tom spoke with JoAnn Gignac about doing the same for City properties. Had a meeting with Paul Pratt and Bill Roesel about the declaration of properties – it went through City Council on the consent agenda. Areas that are now included that are City owned include: Peche Island, Black Oak Heritage Park, Ojibway Park, Spring Garden Natural Area, Oakwood Park. Federal properties aren't yet included, specifically Point Pelee National Park, but it already has the highest level of protection as a National Park.
- d. Compensation Tour and Seminar April 29, 2014 at Ojibway Nature Centre. Dave and Derek attended, Tom attended the tour. A confidentiality agreement was signed, so too much information can't be shared. Within the context of the agreement, they can say: well organized and very informative. Andreas Stencil said we are now up to almost 50 hectares; Chappus Street a worker found Butler's Garter Snake. So, this land has been secured, as well as land at Redock (Cabana and Todd Lane) and the 10th concession. Will have an eco-tunnel for animals that can go right from the Oakwood Bush (PSW as of 2011) over to the Redock area. Have found significant flora (over 200,000) and will make the entire section near the school a Priority Natural Area. Development of snake hibernica. Derek noted that with all combined areas it ends up being over 100 hectares. The members who attended feel that it was a windfall. Another presentation was from EC recovery strategies and the publication of those most of those, when published, will be

open for public comment for 60 days – we need to keep an eye out for those and be sure to participate in the public comment period. Derek added that they have 6 more years of monitoring to do and what will happen to the restoration sites when the monitoring period is done. Dave Munro is very interested in the 'Safe Passage' memorial and determining its original location. If it were determined to be near Ojibway Shores, that would be a great benefit to the cause. First Nations themes will be incorporated into the new 12km walkway. Pete notes that this will be an excellent foundation laid for an ecotourism industry. Derek was particularly interested in was the success rate for the relocation of species – the success rate (according to the presentation) is that they don't have enough years of data to do proper trend analysis.
